- Pursuant to Civil Law No.33/2005/QH11 approved on Jun 14, 2005 by National Assembly of Socialist Republic of Vietnam;
- Pursuant to Business Law No.60/2005/QH11 approved on Nov 29, 2005 by National Assembly of Socialist Republic of Vietnam;
- Pursuant to Law on Insurance Business No.24/2000/QH11 approved on Dec 09, 2000 by National Assembly of Socialist Republic of Vietnam and implementing legislations;
- Pursuant to functions and tasks of each party.

This Co-operation agreement is made today, 1st of June 2023, between

Hereinafter referred to as "BAO LONG"

BAO LONG is an insurance company established and operates under the license No. **XXXX** issued by the Ministry of Finance of the Socialist Republic of Vietnam on XXXXXX.

ATHENA GLOBAL CONSULTING CO. LTD is a company incorporated under the License of Establishment and Operation No 411043002577 issued by Department Planning and Investment on August 30th, 2014.

Both parties agree to sign the cooperation agreement on Travel Insurance with terms and conditions as follows:

Article 1 - Scope of service

This agreement aims to define the scope of cooperation between BAO LONG and Athena on Travel Insurance including but not limited to "TRAVELLA" (travel insurance for individual) and "Adding-Tour".

Article 2 - Responsibilities of BAO LONG

- 1. Provide all materials related to Travel insurance and any other facilities neccessary in the development of travel insurance by Athena,
- 2. Cooperate exclusively with Athena with TRAVELLA Protection,
- 3. Issue insurance Certificates of BAO LONG to clients when they agree buying insurance,
- 4. Send VAT invoices to Athena at latest 5 working days after receiving proposal forms from Athena,
- 5. Request the clients to renew their contracts with Athena (in case any client contacts directly BAO LONG),
- 6. Support Athena to develop this business and **not purposely using client database** of Athena to contact directly to any client.

Article 3 - Responsibilities of Athena

- 1. Product design, underwriting consulting, card and marketing support design,
- 2. Introduce and explain TRAVELLA insurance to clients,
- **3.** Give proper instructions to clients about claim procedure,
- **4.** Delivery VAT invoices, certificate, booklet to the client,
- 5. Collect claim document following claim process,
- **6.** Transfer insurance premium to BAO LONG exactly according to regulation after deduction of commission and/or fees.

It's agreed and understood that the commission, stipulated in the insurance law of Vietnam, is equaled to 20% of premium collected (net of VAT).

Article 4 - Confidentiality

Each Party agrees to keep private and confidential all information obtained pursuant to this Agreement from the other Party(ies). The Parties agree to take all necessary precautions in a manner acceptable to the Party furnishing the information in order to keep private and confidential such information and to restrict its use outside and beyond the scope of this Agreement without the prior written consent of the Party furnishing such information; provided, however, that the above restrictions shall not apply to information:

- 4.1 That was known to the receiving Party when received by it.
- 4.2 That is obtained by the receiving Party from other sources without any duty as to confidentiality or non-use.
- 4.3 That is or becomes generally available to the public through no fault of the receiving Party.
- 4.4 That is disclosed to others by the owner of such information without any restrictions of confidentiality.
- 4.5 That is independently developed by the receiving Party.
- 4.6 The disclosure of which is required by law, court order or any governmental agency; or
- 4.7 That is disclosed to any Affiliates of the receiving Party or any directors, officers, employees, agents, consultants or advisors of such Party or its Affiliates (subject in each case to an agreement as to confidentiality comparable to the provisions hereof) to the extent such disclosure is required or appropriate in connection with the implementation of this Agreement. The disclosing Party must guarantee that such receiving parties shall not disclose the information to any other party.

TRAVELLA is an intellectual property of Athena. BAO LONG and/or its representatives can not use or supply TRAVELLA program to any third party without written approval from Athena.

Article 5 - Dispute Settlement

This Agreement shall be governed by the law of Vietnam.

All disputes, differences or claims arising out of or in connection with this Agreement including, without limitation, any question regarding its existence, validity, construction, performance, termination or alleged violation shall be sought to be settled through friendly consultations between the Parties, upon the receipt of a written request for such consultation. In the event, such dispute cannot be settled through consultations within 90 days of giving such notice, the dispute shall be submitted to the relevant court in Hanoi. The court decision shall have the final binding value to all parties. The court fee shall be paid by the loosing party.

Article 6 – Validity – Term – Amendment – Cancellation of agreement

6.1 - Validity

This Agreement shall become effective immediately upon the signing of the Agreement ("Effective Date").

6.2 - Amendment

Any amendment to this Agreement during its period of validity will have to be mutually agreed upon in writing.

6.3 - Cancellation of agreement

This Agreement has an initial term of one (01) year ("Term") starting from its Effective Date. Upon the expiry of the initial Term, the Agreement shall be automatically renewed with the same terms and conditions unless either Party does not agree to renew it in writing. Such intention must be notified to the other party in writing no later than 3 months prior to the expiry date of the Agreement.

In case, should any Party not carry out fully its responsibilities as stated in this Agreement, the other Party would be entitled to suspend the Agreement within 1 month after having sent an official written notice left without satisfactory response.

In case all the insurance policies are canceled, this Agreement shall be naturally terminated as soon as all outstanding claims have been fully settled.

The termination of this Agreement by cancellation shall not result in any financial compensation between the two Parties.

Article 7 - Miscellaneous

The Parties agree that the preamble of this Agreement, the present and future specific Appendix(ces) to be signed by and between the Parties, constitute an integral part of this Agreement.

In case where any provision of this Agreement becomes void and null by any reason and under any form, the Parties undertake to discuss with each other in order to remedy the reason, which lead to this void and null so that the whole Agreement may continue its validity.

The Parties undertake to exchange and transfer any information, documentation as well as to take any necessary action and decision for the purpose of the implementation of this Agreement.

This Agreement shall be binding and valid to concerning Parties as well as any successor entitled of their rights and obligations as provided in the present Agreement.


Any amendment or modification to this Agreement shall become valid only by written agreement of both Parties.

This Agreement is made into 4 copies (2 in English and 2 in Vietnamese), all texts being equally authentic and each Party shall keep 2 copies (1 in English and 1 in Vietnamese). In case of dispute or any divergence of interpretation, the Vietnamese version shall prevail.
